With the participation of its partners from the Ministry of Education of Colombia, as well as educational institutions, the UTS Bucaramanga (Santander) and SENA Sogamoso (Boyacá), CICan will facilitate a fruitful exchange and present the approach of the "Education for Employment Program in the Pacific Alliance: Sustainable Development and Skills in the Extractive Sector in Chile, Colombia, Mexico and Peru." This Program is an innovative example of international and transnational collaboration in which the education sector has played a leading role in the design and implementation of consortia and cross-sectoral alliances for the reinforcement and outreach of hubs of knowledge and innovation as well as dialogue and synergies between different countries, ministries, municipalities, different levels of training and the productive sector. This parallel session will allow us to revisit the genesis of this initiative, the achievements of the last two years and the challenges that have sprinkled the course of its actors. Because of the diversity of the panel, different points of view will be shared, including those of Colleges and Institutes Canada and that of the Colombian partners.

Fanshawe College is a leading Canadian HE institution that has been working in the past years in creating a model to support the industrial sector with capacity building initiatives in order to fill

Corporate Social Responsibility (CSR) gaps. For us, social synergy means working in sustainable projects by establishing meaningful partnerships with the public, private and non-for profit sectors. We look forward to the engagement in local communities while respecting local values, customs and traditions. At the same time our projects are based on respect for ethno-cultural diversity and equity, open communication and effective interaction with local stakeholders that in most cases improve others' lives especially on educational matters. This presentation aims to show best practices on building partnerships between the academy and private corporations that look into social and environmental ways to build synergies for development on CSR demands.

Flipping it Sideways: A Co-Construction of Horizontal International Partnerships.

- i. Charting a sustainable future for internationalisation through partnership – an Irish higher education perspective.

Knight (2011, 2015) cautions that the values of cooperation and partnership which traditionally characterised internationalisation are being increasingly replaced by those of commercialisation and competition. This paper, based on doctoral research carried out in Ireland, sets out to explore the ways in which, and extent to which this may be applicable. The research findings show that in order to plan for the future, forging closer partnerships with government, industry, civil society and the natural environment are critical in order to enhance 'collective imagining' between stakeholders with a view to developing a solid and sustainable platform for internationalisation.

- ii. Better Together: a co-construction approach of the academic relation with West Africa.

The session will explore the opportunity to develop a new type of partnership between northern countries and West-Africa. Thinking differently the relation in promoting an approach where each partner is equal and part of the project. The session will show how it is possible to change a vertical approach (North to the south) to a horizontal approach (North with the South) in Education and Research in order to initiate a dynamic partnership and a co-construction of future projects. The learning outcomes constitute a new hub of innovation as a synergy for sustainable international partnerships.

In this session, presenters will give the audience insight into the management of international partnership links and the international resource mobilization strategies implemented by local universities belonging to the CCYK network –Colombia Challenge you Knowledge-, as well as the new realities of Colombia and their impact on Higher Education. The CCYK network gathers universities with high quality accreditation status committed to internationalization. Presenters will showcase activities that have resulted in good practices; ranging from successful joint-research and capacity building projects, social engagement initiatives, to innovative international mobility programs. Those will be analyzed from a sustainability perspective, considering the importance of building trust among partners during the early contact phase to ensure lasting and diverse cooperation, the application to external funding opportunities, and quality standards in administrative and academic terms. Key experiences will be featured, highlighting the positive evolution of Colombia and its increasing participation in the field of international education.

La región de Urabá, en el departamento de Antioquia, es un territorio de contrastes. A su invaluable biodiversidad, ubicación geográfica privilegiada y estratégica y enorme riqueza cultural, se contraponen su historia de afectación por el conflicto armado y sus múltiples violencias. La Universidad de Antioquia llega a este territorio con actividades de educación a distancia desde hace más de 40 años y creó su primera sede regional con programas presenciales en 1995, convirtiéndose desde entonces en articuladora de diversos procesos académicos, comunitarios, científicos y culturales. Por medio de alianzas con instituciones nacionales e internacionales, la Universidad ha impulsado un trabajo transdisciplinario, dialógico y participativo, que ha establecido redes de confianza con los actores sociales presentes en Urabá, apuntado a que el conocimiento producido conjuntamente apalanque procesos de desarrollo sostenible de la región. En estos procesos, las redes de cooperación internacional han sido importantes agentes promotores de crecimiento académico.

ii. Knowledge Communities in Social Work

Since 2015, the School of Social Work of the Université de Sherbrooke (Quebec, Canada), has set up a Knowledge Community based on the principles of co-construction of distance reduction between different actors (teachers, professionals, students, users) as well as the valorisation of different types of knowledge (academic, professional, experiential). Thus, several projects have been set up to update a structured and structuring program for involving users in university courses. Based on findings from the literature, the Knowledge Community aims to train better social workers through the participation of the users. It is also expected that these links between the various actors will enhance people's ability to act, thereby becoming an active participant in the profession. In such a context, the university ecosystem opens up to the community through the real involvement and participation of the citizens in training our students.

This session will outline the history, structure and design of cutting edge, unique student-led projects. It will focus on maximizing stakeholder engagement and offer opportunities to discuss how to convert your internationalisation strategies into real results across the board at your institution. Emphasis will

be placed on practical resource planning and time framing, as well as getting maximum student, faculty and employer buy in.

- ii. ProInt: experiences and innovation in a Brazilian educational, research, and community outreach university program.

In this session, we aim to narrate and compose meanings of experiences lived in the design, implementation and evaluation of an ongoing educational, research, and community outreach program developed by students and coordinated by Universidade Federal de Uberlândia (UFU) teachers: ProInt. We explain how the innovative design of having a team of undergraduate students from a diverse array of departments think of ways to contribute to the internationalization of higher education, which was a task restricted to faculty and staff, has broadened horizons. We also illustrate what was learned in the trajectory narrated: how to increase the visibility of integration, cross-cultural dialogue, and internationalization at home, working for the benefit of international students the entire community. We conclude by arguing for our desire for each student, incoming and outgoing, to bring a part of Uberlândia to the world, and for international students to leave their marks on our university.

Esta mesa presenta tres iniciativas del programa CAMPUS-OUI, a través del eje Social-CAMPUS, para construir redes de colaboración interuniversitaria. El programa (e)MOVIES provee alternativas de movilidad virtual para estudiantes que no pueden afrontar los altos costos de movilidad física. La Cátedra Laudato sí', vincula a universidades alrededor del trabajo colaborativo para el cuidado del medio ambiente y nuestra "casa común". El modelo de investigación interinstitucional, multidisciplinaria que se presenta en la tercera ponencia integra y recoge las fortalezas disciplinarias y experiencia construidas en diferentes instituciones, Son iniciativas para hacer frente a problemas comunes creando sinergias, reduciendo la duplicación de esfuerzos.
